20 WHEREAS, the Motion for Summary Judgment of Defendant IRIGOYEN FARMS,
21 INC. ("Irigoyen Farms") came on regularly for hearing on August 9, 2023, in Department
22 403 of the above-listed court, before the Hon. Jonathan M. Skiles, judge presiding, after
23 consideration of all the pleadings, moving and opposing papers, the admissible evidence,
24 and oral argument, the Court GRANTED the Motion for Summary Judgment in favor of

8 Irigoyen Farms shall be awarded costs against Plaintiff CHRISTINA CASAREZ,
9 individually and on behalf of the Estate of Olivia Mendoza, and Cross-Complainant
10 JAIME MENDOZA, individually and as Successor-in-Interest of decedent Olivia
11 Mendoza according to proof.
